
Sofia Pride Human Rights Forum 2023 is first of its kind and will be co-hosted by Bilitis and GLAS foundations, the Embassy of Sweden in Sofia on the occasion of the Swedish Presidency of the Council of the European Union, and the LGBTI Intergroup at the European Parliament.

The aim of the Forum is to create space for discussion around two topics of great importance to the LGBTI community in Bulgaria - hate, freedom and security, and the rights of rainbow families.
